

Personal Data Protection Policy

Personal information security is a matter that is closely monitored within the company J&R Enterprises SRL. Thus, our company ensures the protection of your personal data in accordance with the provisions established in the applicable data protection legislation in Romania, including the Regulation (EU) 679/2016 regarding individuals' protection as regards personal data processing and regarding the free circulation of such data.

Personal data is any information referring to an identified or identifiable individual, and an identifiable person is a person who can be identified either directly or indirectly, especially by reference to an identification number or to one or several physical, psychological, mental, economic, cultural or social identity specific factors.

The informing as regards personal data processing applies to all interactions with the website <https://www.jaren.ro> and also to other situations as described within this document.

The personal data we are processing

- your identification data (full name);
- your contact data (e.g.: telephone number, e-mail, etc.)
- data obtained on the occasion of visiting the website <https://www.jaren.ro>, by means of cookies (IP address, visit duration, the location of the device you are using to log in, your interaction history, protocol data, type of browser, etc.)

Personal data collection purpose

The collecting of your personal data is strictly limited to what is required for the purposes of J&R Enterprises SRL and shall be strictly limited to the following:

1. Activities regarding the purchasing of services/products;
 - the concluding and executing of the agreement and rendering of the services;
 - other activities and actions derived from the concluding and executing of the agreement.
2. Activities carried out as part of procedures for getting acquainted with the clients.
3. The profiling for direct marketing purposes of the clients visiting the website <https://www.jaren.ro>, based on the existing cookies.

Any processing of your data for the purposes as mentioned above is based on one of the following grounds:

- The execution of an agreement (e.g. the agreement regarding the purchasing of services/products) – the following personal data are processed: your identification data (as a client being an individual or as a representative or other employee of a client being a legal entity), your contact data and your position;
- The fulfilling of certain obligations provided for by the legal provisions on the side of J&R Enterprises SRL.
- Your consent given on the occasion of visiting the website <https://www.jaren.ro>.

Personal data collection, storage and security

We are collecting the personal data you are voluntarily providing us with both at the time you are contacting us (e.g. for the preparing of a services/products offer), and at the time of initiating the contract obligations, and subsequently, during the carrying out-of the contractual relationship. Please be informed that, you are free to decide whether to provide us with such personal data or not. However, in absence of those, carrying on of the contract relationship will not be possible.

Your personal data are collected directly from you, by means of written forms, agreements and/or other similar documents, by telephone or by e-mail and by means of the cookies of the site <https://www.jaren.ro> you are visiting (based on your consent). On an ancillary basis we are also collecting your personal data available on public specialty sites and/or other public information sources in order to contact you for possible collaboration purposes.

Your personal data will be stored for a limited time period, which is determined considering the time of ceasing the contract relationship, and any other existing legal obligations to keep certain data beyond such period.

J & R ENTERPRISES SRL may provide the user's personal data to other entities they have a partnership with, but provided their confidentiality is being preserved, which guarantees that the personal data are kept safe according to the legislation in force.

Such partners may be: shipping or courier companies, marketing services companies, banking or payment services companies, insurers or companies developing customised interfaces and software for J & R ENTERPRISES SRL.

The security, integrity and confidentiality of your personal data are very important to us. J & R Enterprises SRL shall take all the organisational and technical actions deemed required for such purpose.

Changes to this informing policy

J & R Enterprises SRL may change this informing policy without prior notice, depending on the legislative requirements in force. When we make changes to this informing letter we will specify the date the information was updated on. We recommend that you periodically read our personal data processing policy, ~~again~~ in order to stay informed on the manner our company is protecting your personal data.

Your rights

You have the following rights regarding the processing of your personal data:

- The right to be informed.
- The right to request access to your personal data the company is processing.

- The right to request the rectifying of the personal data that are incorrect, incomplete or have not been updated, and also the deleting of your personal data, for example in the case where the processing of the same is not required or is unlawful, or when you are withdrawing your previous consent to the processing of such data. The personal data required to be kept in accordance with the legal provisions may not be deleted.
- The right to restrict the processing of your personal data, by your request and under the conditions provided for by the law.
- The right to oppose, namely you may exercise your right to object as regards personal data not required by imperative legal provisions, not required for the purposes of execution the agreement concluded with the Company, and not requested by the Company based on its legitimate interests. You also have the possibility to withdraw your consent regarding the personal data thus provided, which withdrawing may be expressed at any time and leads to the personal data concerned being deleted from our database within the shortest time possible; as regards the other personal data collected, based on a legal obligation, the withdrawing of the consent shall have no effects.
- The right to data portability.
